County defensible space inspections have started in Washington with being one third done. 43 notices issued with 17 corrections issued. County working on compliance not fineing people. Mike is going with a county worker for safety reasons. All of Maybert and Relief Hill road are completed. Mike is working with a countyperson on getting the \$ 10,000.00 promised but

have not paid yet they are working on paperwork and insurance requirements. Mike stated will get the money just as a matter of when. County sent a worker to check on the repeater on Cherryhill for us and the batteries are bad and will cost \$400.00 dollars. The county will take care of the cost somehow. County fire resources being impacted by the covid-19. Firefighter and hit hard with filling in on overtime and man power. Fire got a call for one of the campgrounds and when the paramedic showed they stated that this was their eighth call for covid that day alone. Mike had his chiefs meeting by zoom they talked about the new ( AVL) All vech system that is a tracking system for responding vehicle location so they can see where the closest vehicle is to send for faster services.
