CA Code 4291 Defensible Space of 100 Feet is the law and is going to be used by the State and local governments to generate action by property owners to have defensible space and going forward may become part of real estate transactions where a seller meets defensible space requirements when selling property.

- D. Pettis moves to approve, W. Ahrens 2nd- ALL APPROVE
- B. Director's Announcements (Directors) NONE
- C. System Operations Report: (S. Rowland)
 - S. Rowland tells Board that she is now Operator of Record and as such is beginning to put together and turn in all required reports- Annual Report, Consumer Confidence Report,

Monthly CT Report, Diversion Filings- she is also working to stay up on all required compliance testing and reporting.

Since the last meeting, Tyson fixed the major leak on Maybert Rd saving the Board about 80,000Gal of water a day, he also got the pacer/meter repositioned.

There is a small portion of exposed water main in a customers driveway- this customer says that he would like the Board to get a 10-wheel dumptruck of gravel to cover the line and that he would pay half of the cost and if the Board does not follow his recommendation he would like them to sign a paper for his insurance stating that he will not be held responsible if the pipe breaks.

W. Helm asks L. Hillmann to find the cost of gravel-

 readings are done and in to Jessica- no new leaks to report
- II. Old business: for information, discussion and possible motion.
 - A. Labeling of meters (L. Hillmann)
 - L. Hillmann tells the Board that she is just about done- there was some confusion with getting the meter numbers assigned, but it is taken care of now and the next readings will be done with pictures
 - B. Workman's Comp issue (S. Rowland/C. Jackson)

Charity explains how Workmans' Comp works through State Fund. She told the board that the Fire Department has coverage for 5 people through May 2019. Charity recommends that the board DOES NOT reduce coverage-that the state will go after board members individual assets. Charity is working to get at least 3 quotes and more info on Associations that require membership and at least one quote from an Association. She spoke with Captain Cole about a possible cap on volunteers

the Board should decide on whether to put a cap on volunteers or allot more money for coverage Discussion about work comp codes/ estimates for man hours

this is one of the questions that Charity is asking all companies

Charity hopes to have more definitive answers for the Board at April meeting

C. Late charges (W. Helm)

- W. Helm would like to consider this again- there is a policy with a \$75 Admin fee but no one has ever had their water turned back on, so the fee has never been paid
- W. Helm says that 10% of \$50 is only \$5 but there would be a consequence for the people that habitually pay WCWD late
- W. Helm moves that a 10% late fee be placed on bills over 30 days- to begin in May 2019
- W. Ahrens says that if they cannot pay the bill then they would not be able to pay the late fee
- W. Helm says that this is for the people that do pay but are consistently late

In Depth Discussion of this and other options-

Charity suggests shelving this issue until other billing problems are resolved

W. Ahrens wants to remind everyone of how bad things were before Jessica was our bookkeeper-

Discussion of possible illegality of sending out bills without meter information on them W. Ahrens brings up the fact that not everyone has a meter to be billed by

-W. Helm stops the discussion-

this is not the time or the place- this will be on next agenda

Charity informs the Board that people are going to call the County and she is concerned that the Board is not in compliance

W. Helm again moves to start charging a 10% late fee in May of 2019

K. Kozloski would like to see how this would actually affect the finances DISCUSSION......

W. Ahrens says that soon the District should go back to ditch water

K. Kozloski asks what exactly is being discussed....

- A. Exposed pipe in John Weinman's driveway (S. Rowland)- covered in OP Report

W. Helm tells the Board that he and S. Rowland had a conference call with EFN- they offer free help to water systems for looking at rates and compliance issues and also will look at P&P to be sure they are in compliance

C. Webinar (W. Helm/L. Hillmann)

this webinar was about Board roles and responsibilities...

General Public Comment

General Public Comment time (not related to existing agenda items) allowed on subjects relating to the water agency and/or Fire Department, total elapsed time **15 minutes**, **3 minutes per individual speaker**.

Jim Grill (public) would like to revisit the rates that were suggested by RCAC- he spoke with Mary Fleming (RCAC) and she agrees that there may be errors in the report

he would like to set up a committee to work on this with Mary- W. Ahrens agrees and volunteers to help with this

Jim Grill believes that if meters were to be put on each APN at both campgrounds for all permanent residences that the District could get up to \$40,000 in water sales each year

Joe Lidwell (public) says that the base amount of 5000 gal a month is not sufficient- K. Kozloski says that it is a reasonable amount of water

Joe says to find the operating cost per year, divide by number of customers and charge that amount and let everyone use as much water as they want

Joe also has concerns about landlords being responsible for tenant water bill- he is told that this is State Law

Discussion of deposits for service

Closed meeting for personnel matters - audio of closed session is available for Board members upon request

RESULT OF CLOSED SESSION:

the Board unanimously agrees to give S. Rowland \$30/hr, plus \$800/month for healthcare- if this is not legal they will up hourly pay- and for emergencies \$90/hr to be reviewed in 3 months effective March 16, 2019

this will come with a more defined job description which K. Kozloski and S. Rowland will work on in the coming weeks
